#### **CPT Coding Issues**

As you're all well aware, major changes to the CPT coding used by psychiatrists went into effect on January 1, 2013. As I write this the payers continue to be all over the place in their responses to the new coding. We met with the major payers before January 1 in an effort to ensure that they would be able to make the transition smoothly and several of them have accomplished this feat reasonably well. We continue to work with the many payers who have apparently been unable to adjust their systems to maintain appropriate reimbursements under the new coding format.

Unfortunately, the apparent inability of many payers to at least maintain the reimbursement levels psychiatrists were receiving in 2012 has created a number of problems for APA members and their patients. The problems seem to differ from plan to plan and even from psychiatrist to psychiatrist within a plan's network. Some of the issues the Office of Healthcare Systems has heard about with some regularity are:

- Plans' inability to process the two codes now needed to represent psychotherapy with
  medical evaluation and management (E/M), previously coding using one code with
  minimal value given to the E/M, which is often a major part of psychiatric care. There are
  variations on this with some plans paying only for the E/M code, while others pay only
  for the psychotherapy code.
- Plans paying for the two codes, but at such reduced fees that psychiatrists are receiving
  less than they did for providing the same services in 2012 when they had no means of
  accurately representing the E/M work they performed.
- Plans charging patients two co-pays for a visit with a psychiatrist because two codes are
  used to record the visit—something that never occurs with visits to primary care
  physicians who often use several codes for a patient encounter.
- Plans requiring prior authorization for the use of E/M codes 99214 and 99215.
- Plans not paying anything at all because of computer problems with processing the claims.
- Plans refusing to recognize and/or pay for the psychotherapy add-on codes (90833, 90836, and 90838).



Serious problems have also been created for out-of-network psychiatrists whose patients, while continuing to pay the psychiatrist the same fees as in 2012, are running into the same payment problems mentioned above.

We have an ongoing program of liaison with payers regarding these issues and are launching a new focused effort aimed at amelioration. Where resolution is not forthcoming, the APA will commence an even more focused action with the problem payers and will consider all appropriate options as necessary see link below.

We will report these developments to you on a regular basis. It is important that this be a two-way communication loop, and we continue to urge you and your members to report on issues with payers as they occur. At a minimum we ask that you or the member provide the name of the payer, the nature of the problem and their contact information so we can follow-up with them for more details. #### **Distinguished Fellow**

APA has provided the list of WPS members who are eligible for Distinguished Fellow status in 2013. Distinguished Fellowship is awarded to outstanding psychiatrists who have made significant contributions to the psychiatric profession in at least five of the following areas: administration, teaching, scientific and scholarly publications, volunteering in mental health and medical activities of social significance, community involvement, as well as for clinical excellence. Distinguished Fellow is the highest membership honor the APA bestows upon members.

The process entails submission of a completed nomination form and references letters from current APA Distinguished Fellows. If you are eligible and have provided an email address to WPS, you will be receiving a package that includes the nomination form, guidelines, sample references letters, and a list of current Distinguished Fellows.

Those who are eligible but have not provided an email address will receive the same package via mail. Completed packages must be submitted Christine Cotter with WPS by June 1, 2013. The WPS Board will review the submissions for further delivery to APA by July 1, 2013. APA will make the final decisions in the fall.

#### **Updates on Past Events**

#### WPS- Member Area III Council Meeting, Philadelphia, held March 16, 2013

Area III Council consists of Assembly Members from Area III, Area III being Delaware, Maryland, New Jersey, Pennsylvania, and WPS. Among the two dozen attending, seven WPS Members: Urooj Saeed [Area III MIT Deputy Representative], Beth Morrison [WPS Assembly Representative], Brian Crowley [Area III Trustee on APA Board of Trustee], Bill Narrow [APA Headquarters], Richard Ratner [American Society of Adolescent Psychiatry Representative]. Eliot Sorel [WPS Assembly Representative], and me [WPS Assembly Representative].

The Assembly meets twice a year and at each meeting considers twenty to thirty motions ["Action Papers"], which helps set the agenda of the APA [e.g., calling for the development of Practice Guidelines in 1989]. Year after year since Oscar Legault joined the Assembly as WPS Assembly Representative in 1974, WPS has been prominent in initiating Action Papers. At this meeting, Area 3 passed 7 Action Papers:

- 1. That self-defense training be part of training of psychiatric residents [Urooj Saeed, primary author].
- In APA elections, there has been tight rules as to the degree that campaigning can be
  done on District Branch [DB] electronic communications. Maryland has an Action Paper
  to open up campaigning on DB electronic communications, such as the DB listserv.
- That the name of the APA Committee on Electronic Health Records be renamed the Committee on Mental Health Information Technology and that the Committee's mandate be broadened [Maryland motion].
- 4. 4. That the APA have representation on Health Level 7 [HL7] [Maryland motion]. HL7 is an organization that fuels the language of health information technology.
- 5. That the APA establish an Ad Hoc Work Group on Gun Violence [New Jersey motion].
- 6. That the Practice Guideline Task Force develop a general guide on the use of more than one psychotropic medication in the treatment of psychiatric disorders [WPS motion].
- 7. That DSM-5 be provided free to all APA Members, that is, DSM-5 be seen as an APA Member benefit [WPS motion].

Next hurdle for these motions is the Assembly that will meet in juxtaposition to the APA Annual meeting in May in San Fracisco. As a rule, we have seen about half of WPS Actions Papers pass the Assembly, about a fourth fail, and about a fourth pass in a compromised state to where is it hard to judge if it was a lost or a win.
